Textual Information(1)	On July 22, 2025, the company has applied for BSE "in-principle" approval to issue 2,500,000 preferential warrants to Mahalaxmi Import Export Private Limited, one of our promoter company. After several rounds of queries, we received in principle approval on November 19, 2025. However, due to this delay, the proposed allottee has redeployed the funds intended for the subscription. As a result, the promoter company is no longer intested in proceeding with issue hence, the company has not proceeding with the said preferential issue.Hence the current lock in of mahalaxmi shares stands void and will get released on January 15, 2026 by NSDL. Accordingly the said lock in will not be applicable from next quarter onwards.
